Praise be to the God and Father of our Lord Jesus Christ! In his great mercy he has given us new birth into a living hope through the resurrection of Jesus Christ from the dead.... (1 Peter 1:3 NIV)

hy do babies capture all the attention in a room? I remember when my children were born; I was full of anticipation and joy—and a little fear. We received baby showers and parenting advice from family and friends. One strong memory was the number a diaper packages we were gifted. Yikes! For us a newborn baby was the start of something altogether new, different, and wonderful. And by looking at all the pictures and videos we have of our children, you would have to conclude that our attention, too, was captured by new life.

Can you think of a time when you were enthralled by new life? Perhaps you've recently welcomed into the family a grandchild or great grandchild. New life gives hope. It shows us what is possible. What brings you hope? The Bible passage above announces new life in Christ that offers a *living* hope.

#### Letter from the Foundation The difference of a 501(c)3

Governance by a mission-driven board of directors, instead of profit-driven stakeholders, fuels the purpose of our organization.
